Dr. B. W. Kingrey, head of the Department of Medicine and Surgery, attended a meeting of the Central Illinois Veterinary Medical Association at Urbana, Illinois, on May 13, 1960. Dr. Kingrey presented a paper entitled "Cattle Practice." **Dr. Philip Pearson** attended the same meeting presenting papers on "Orthopedic Problems in the Hip Region of Small Animals" and
