Dr. Pals Heads Meat Inspection

Appointment of Dr. Clarence H. Pals as director of the Meat Inspection Division of the U.S. Dept. of Agriculture, was announced effective Sept. 1, 1960. Dr. Pals is a 1932 graduate of the Iowa State University, College of Veterinary Medicine. He succeeds Dr. Albert R. Miller (ISU '24) who headed the Meat Inspection Service since 1944.

Dr. Pals joined the USDA in November 1932 as a veterinary meat inspector at Chicago. Subsequent field assignments took him to Fort Dodge, Iowa (1934-39), to Esterville, Iowa (1939-40), and Sioux City, Iowa (1940) as assistant inspector in charge. In 1941 he went to New York

as assistant inspector in charge. Dr. Pals came to Washington in 1944 and was named chief of the trade label and standardization section.

Dr. Pals was born in Meservey, Iowa, in 1907, and grew up on a general livestock farm. He attended public schools and Iowa State Teachers College and taught rural school in Iowa prior to entering veterinary school.

Dr. Pals is vice-president of the International Association of Veterinary Food Hygienists, past chairman of the food hygiene committee of the American Veterinary Medical Association and a member of the Commission for Foreign Veterinary Graduates.

Dr. and Mrs. Pals have two children, a daughter and a son. The son, Dr. Calvin H. Pals, was an ISU graduate in veterinary medicine in 1959. The young Dr. Pals is now located at Chicago, Illinois with the U.S. Army.
