Class of Fall 1943

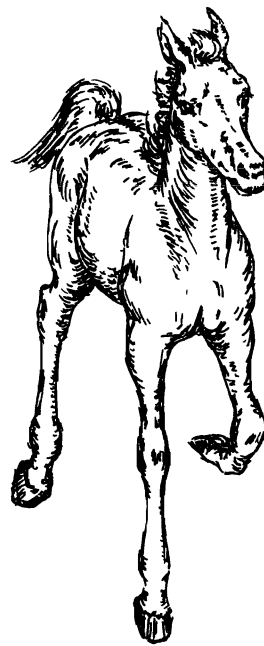
