DOG SHOW

According to a recent announcement by the Veishea Central Committee, the 1953 Veishea Dog Show will again be sponsored by the Division of Veterinary Medicine. George Beran and George

The dogs will be on exhibit Friday, May 15, with special acts to be presented in the morning and afternoon. A registered puppy will be given away as a door prize at each act.

Members of the procurement committee would appreciate any help that practitioners could give them in mentioning the purpose of the exhibit to their clientele. It is to be understood that the show is merely an educational exhibit and that there will be no direct competition or prizes awarded. Proper facilities for exhibiting both the dogs and previously acquired ribbons or trophies will be available.

Calcification is a common regressive phenomenon in cartilage. It is also known that calcium may be absorbed after it has been formed; therefore, a calcified disc may appear normal at a later x-ray. It is also recognized that while calcium indicates degeneration of a disc, it does not necessarily mean that the calcified disc has protruded or that it is to be considered a cause of symptoms.

According to William J. Mayo of the Mayo Clinic in Rochester, Minnesota, the clinic has never charged a physician or a clergyman or any dependent member of the family of either . . . they have never taken notes at the clinic. No mortgage has ever been given on a home to pay a bill there. They never sue. Thirty percent of the patients are charity cases. About 25 percent pay barely the cost of the treatment.
